Over the next year, the company will work on modifying the troubled plant and then spend about six months to commission and ramp up the mine.

It expects the works to cost about \$US150 million (\$A171.47 million).

Ravensthorpe was controversially closed down by BHP Billiton Ltd in January 2009, amid difficulties in exploiting the nickel laterite deposits and plunging prices of the metal.

The nickel mine cost about \$US2.1 billion (\$A2.4 billion) for BHP to build and when it closed, 1800 people lost their jobs, a huge economic blow to the town of

Ravensthorpe.

The mine is located about 550km southeast of Perth, and First Quantum expects it will produce 39,000 tonnes of nickel each year for the first five years and 28,000 tonnes annually after that.

The mine's expected life is 32 years.

# Quantum leap for Ravy

RAVENSTHORPE residents woke up yesterday optimistic about the town's future after the Canadian miner which bought the mothballed BHP Ravensthorpe Nickel Project last year announced the mine should be up and running within 18 months.

First Quantum Minerals formally took control of the site on Wednesday after receiving Government approvals and announced in the next year it will work on modifying the troubled plant and then spend about six months to commission and ramp-up the mine.

Ravensthorpe shire president Ian Goldfinch said it was good news for the town.

"With Galaxy already starting to put people into the district and Tectonic possibly coming online in 18 months we could be back where we were with BHP," he said. Galaxy Resources is developing the Mt Cattlin Lithium Project and Tectonic Resources' Phillips River Project has a wealth of gold, silver and base metals.

"There will be many more focused people in town and we will be flat out trying to find accommodation for everyone

agam," Mr Goldfinch said.

He said shops and businesses in Ravensthorpe and neighbouring Hopetoun had "hung in there" after BHP closed its doors in January last year amid difficulties in exploiting the nickel laterite deposits and plunging prices of the metal.

"The mood was low; people didn't know what their future was," he said.

"They didn't know whether to sell up and leave. But the shire and local chamber of commerce put in a lot of work and looked at tourism."

The State and Federal Governments recently committed funds to develop roads in the region's Fitzgerald River National Park.

"Now we have two strings to our bow," Mr Goldfinch continued.

"You never know with mining when it's going to stop."

Mr Goldfinch said the atmosphere in Ravensthorpe was positive, but the town would be more careful this time around.

First Quantum expects its works to cost about \$171.47 million.

The nickel mine cost about \$2.4 billion for BHP to build and when it closed 1800 people lost their jobs – a huge economic blow to

the town of Ravensthorpe.

The mine is about 550km south-west of Kalgoorlie-Boulder, and First Quantum expects it will produce 39,000 tonnes of nickel each year for the first five years and 28,000 tonnes annually after that.

The mine's expected life is 32 years. Bruce McNally from the Ravensthorpe Hopetoun Media Liaison Group said working with First Quantum was in stark contrast to his dealings with BHP Billiton.

"BHP are a massive bureaucracy, far more complex than any Government bureaucracy and therein lies their incompetence," he said.
